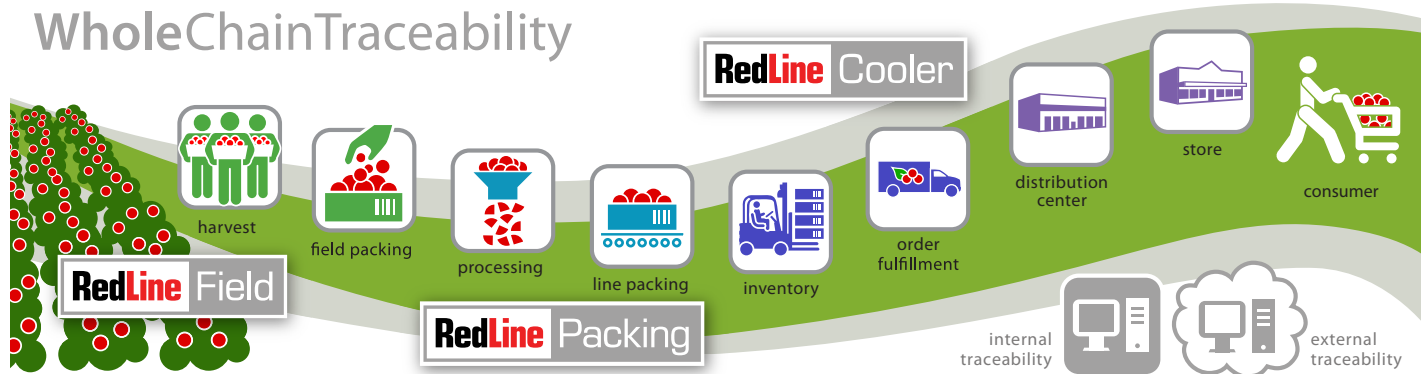

WholeChainTraceability

Consumers today are demanding increased information and guarantees about the safety of the food they eat. In response, the major produce associations—PMA, United Fresh, and CPMA—partnered with leading retailers and growers to define the Produce Traceability Initiative (PTI). Currently, the FDA, USDA, and US Congress are working on legislation and regulations that will mandate food traceability in the near future. We expect these mandates to require companies to label each case of produce with a product ID and lot number, and to maintain this information electronically. Upon request from the FDA, these records must be provided within 24 hrs. Case level tracking is inevitable because it connects each link in the path between the original packer and every participant throughout the supply chain. Together, the industry and government initiatives drive the requirement for increased traceability compliance throughout the fresh produce industry.

Whole Chain Traceability is based on standard information that provides links between individual companies' internal traceability¹ systems enabling external traceability throughout the supply chain. External traceability² allows coordination between the FDA and all members of the supply chain when a food borne illness issue is suspected.

PTI Milestone #3 required brand owners to submit their Global Trade Identification Numbers (GTIN) to their buyers in Q3 2009. Milestones #4 and #5 require brand owners to label every case of produce shipped with both GTIN and the lot or batch number beginning in Q3 of 2010. GTINs identify the supplier, commodity and pack style of the product; Lot IDs identify when and where the product was packed. Case traceability labels must identify the GTIN and the Lot ID in human-readable and barcode form. While putting a label on a box sounds simple, getting the correct label on each box is complex. Because harvest or pack runs can change throughout the day, the process of case level traceability compliance can seem overwhelming.

Flexible PTI Compliance from Harvest to Cooler

RedLine Field is a simple and thorough solution that allows you to track field-packed produce from the point of harvest until it reaches the Cooler. It also provides in-process visibility into your harvest operations through detailed reports highlighting crew productivity and harvest results.

Every growing operation is different, driving unique requirements for generating and applying case traceability labels. RedLine Field allows you to print labels when and where you need them including pre-printing labels in bulk at the office, printing directly in the field, or printing at the cooler upon receipt. You can mix and match how and where you print your labels, even changing it from day to day.

Traceability compliance starts with the daily estimate or harvest plan you already use. For each commodity, this plan spells out what, where and how many cases you plan to harvest, as well as the crew(s) and specific items to pack from each field. The harvest plan provides the basis for printing and applying traceability case labels. Since the plan is often adjusted during the day to reflect customer requests or field conditions, RedLine Field provides the flexibility to adjust to these changes on the fly.

Once your harvest team has done the work to print and place the correct label on each case, the process of tracking begins. As pallets are built, the harvest crew associates the case labels to a pallet tag using a mobile device. This process only takes a few seconds to build the electronic record which is the key to traceability. Once the harvest data has been captured, pallets can be tracked to the cooler where the traceability information automates the receiving process, saving time and reducing data entry errors in the receipt process.

Streamlined Inventory Management

RedLine Cooler helps you quickly and accurately track products from the moment they are received at your cooler or processing facility until they are successfully shipped to your customers. RedLine Cooler increases your operation's throughput, reduces shipping errors and improves your traceability compliance.

From the moment you receive the product from the field or your packing line, RedLine Cooler starts the record-keeping for your internal traceability. You can track your products' movement through your facility including pre-cool or treatments, electronically recording a full audit trail of each pallet's activity.

Flexible PTI Compliance in the Packing Shed

RedLine Packing is a complete solution that allows you to track bulk-harvested produce from arrival at your packing shed until it has been packed and is ready for shipment or storage in the cooler.

PTI-compliant traceability on a packing line is a significant challenge, particularly in high volume packing operations with multiple lines and multiple products. You must identify the product, pack style, and packing lot of each case of produce in order to get the right label on the box. Combine this with the need to tie the packing lot back to the source lot(s) and you have a real challenge.

Traceability compliance starts by tracking incoming bins of produce, including their source lot, within the packing operation. As the line operator views grower inventory and selects which source lots to pack, the system validates that the bins dumped onto the line are from the selected lot(s) to prevent unwanted co-mingling.

After selecting source lots, the line operator specifies the pack styles being packed at each drop on the line. When multiple items are packed at a specific station, each case's pack style is identified by the packer. As completed cases move down the line towards the palletizing operation, RedLine Packing automatically generates the correct PTI label based on the scanned information. The labels are then placed on each case using an in-line print-and-apply process.

As pallets are built, case information is associated to a pallet tag. This process builds the electronic record which is the key to traceability compliance. Completed pallets are tracked to the cooler where the traceability information automates the receiving process, saving time and reducing data entry errors in the receipt process.
